Dear Property Owner,

At 7:00 p.m. on February 10, 2011, the Avon Water Pollution Control Authority met and held a Public Hearing in the Selectmen's Chambers of the Avon Town Hall concerning the Deepwood Drive sewer assessments. The proposed assessments were accepted and levied on benefitting properties. A copy of the assessment values levied was filed in the office of the Avon Town Clerk on February 11, 2011, and is included here.

In accordance with State Statutes, owners could appeal their assessment to the Connecticut Superior Court within twenty-one (21) days after the date of filing with the Town Clerk. Accordingly, the appeal period closed on March 7, 2011.

A packet of information was mailed to you with your notice of the public hearing regarding these assessments. As described in the packet, the assessment payments are scheduled to be due on August 1, 2011. In addition, and as outlined in the packet, there is an option to pay your sewer assessment on a 10-payment installment schedule. If you have not already responded and if you are interested in this option, please complete and return Enclosure # 4 of the previous packet – a copy of which is included with this letter.
